Acceptance of the Terms of Use

These terms and conditions of use are entered into by and between You and Dolls and Dandy, Inc., a California corporation ("D&D", "Company", "us" or "we"). The following terms and conditions, together with any documents they expressly incorporate by reference (collectively, these "**Terms of Use**"), govern your access to and use of www.dollsanddandy.com, including any content, functionality and services offered on or through www.dollsanddandy.com (the "**Website**"), whether as a guest or a registered user.
